

## **STANDARD TERMS AND CONDITIONS FOR COMPETITIONS:**

### **Win a personalised Stellenbosch FC home or away jersey campaign – 4 November 2023**

These are the standard terms and conditions for competitions conducted or promoted by or in association with Stellenbosch Football Club.

1. Your entry into the competition and/or your acceptance of a prize (in the event that you win a prize) constitutes your binding acceptance of the terms and conditions.
2. The competition is not open to directors, members, partners, agents, or employees of Stellenbosch Football Club or its affiliated companies, or any supplier of goods or services in connection with a competition; and the spouse, life partner, business partner or associate, or the natural or adopted parent, child, or sibling, of any of the persons employed by Stellenbosch Football Club or its affiliated companies.
3. Entrants under the age of 18 must obtain permission from their parents or guardians before entering the competition.
4. It is your responsibility to ensure that the information recorded on your entry form is correctly captured. Any entries that are not correctly captured or which contain erroneous contact and relevant personal details will not be eligible to participate.
5. It is your responsibility to ensure that any information you provide to us is accurate, complete, and up to date.
6. Any costs or expenses which you may incur other than in respect of those items specifically included in a prize are for your own account. Neither Stellenbosch Football Club nor its affiliated companies will be responsible for any costs or expenses that you incur during and for purposes of your entry into the competition and your acceptance and/or use of a prize.
7. We do not make any representations or give any warranties, whether expressly or implicitly, as to a prize, and in particular, but without limitation, make no representations and give no warranty that your entry or participation in the competition will necessarily result in you winning a prize; a prize, or any aspect thereof, will meet your requirements, preferences, standards or expectations; or a prize, or any aspect thereof, will be satisfactory, punctual, free from defects, safe or reliable.
8. We and our affiliates will not be responsible for any harm, damage, loss, or claim relating to the provision of any element of a prize or any changes to a prize that may be made at any time. Prizes are not transferable and may not be deferred, changed, or exchanged for cash or any other item.
9. You may not win a prize if it is unlawful for us to supply such a prize to you. If you do win such a prize, you will forfeit it.
10. The winners will be notified by means of the contact details provided to us. If we are unable to contact a winner within three (3) working days or if the winner is unable to collect the prize

within a reasonable time, the winner will forfeit the prize and Stellenbosch Football Club reserves the right to re-draw a new winner under the same conditions.

11. We may invite you to be present when the prize winners are determined or announced, to participate in any of our marketing activities, to appear in person in the electronic media and/or the print media, and/or to endorse, promote or advertise any of our goods or services, for which no fee, royalty or other compensation will be payable. You may decline such an invitation.
12. We may publish the names of the participants and winners on any of our communication platforms.
13. We may require you to provide us with such additional information and documentation as we may reasonably require processing, confirming, and facilitating your acceptance and/or use of a prize. If you refuse to provide us with the requested information or documentation, you will forfeit the prize. All such information will be processed in accordance with the Protection of Personal Information Act, 2013.
14. We reserve the right to vary, postpone, suspend, or cancel the competition and any prizes, or any aspect thereof, without notice at any time, for any reason which we deem necessary. In the event of such variation, postponement, suspension, or cancellation, you agree to waive any rights, interests, and expectations that you may have in terms of this competition and acknowledge that you will have no recourse against us or our affiliates.
15. You agree that your participation in the competition, and your acceptance and/or use of a prize, or any aspect thereof, is at your own risk. We and our affiliates will not be responsible, and disclaim all liability, for any loss, liability, injury, expense, or damage (whether direct, indirect, incidental, punitive, or consequential) of any nature, whether arising from negligence or any other cause, which is suffered by your participation in the competition or the acceptance and/or use by you, or your partner (if applicable), of any prize, or by any action taken by us or any of our affiliates in accordance with the terms and conditions.
16. In the event of your death, your family, dependents, heirs, assignees, or any other beneficiaries of your estate, indemnify and hold us and our affiliates harmless against any claim by you (whether direct, indirect, incidental, punitive, or consequential) of any nature, whether arising from negligence or any other cause, relating to any injury, loss, liability, expense and/or damage which you may suffer, howsoever arising, in relation to your entry into this competition and/or acceptance and/or use by you of a prize.
17. Any minor will be accompanied by a parent or legal guardian.
18. If you fail to comply with any of the terms and conditions, then without prejudice to any other remedy which we may have you will be automatically disqualified, and you will forfeit the prize. In the event, that you have already won a prize, you will pay us for any loss or damage incurred by us directly or indirectly as a result of your noncompliance, including all our legal costs (including attorney and own client costs) which we may incur in taking any steps pursuant to your non-compliance; and you indemnify and hold us and our affiliates harmless against any claim by any person, (whether direct, indirect, incidental, punitive or consequential) of

any nature, whether arising from negligence or any other cause, relating to any death, injury, loss and/or damage which may be suffered howsoever arising in relation to your failure (or that of your partner, if applicable) to comply therewith.

19. For purposes hereof, "affiliate" means our partners, co-promoters, and sponsors of this competition, our subsidiaries, our and their subsidiaries and respective holding companies, the subsidiaries of their holding companies, and our and their directors, officers, employees, agents, and representatives.
20. These terms and conditions will be construed, interpreted, and enforced in accordance with the laws of contract and dispute resolution in the Republic of South Africa.
21. Stellenbosch Football Club and the judges' decision on any matter concerning the competition and/or arising out of these terms and conditions is final and binding on you, and no correspondence will be entered into.
22. This competition runs from 11h00 until 16h00 on 4 November 2023. To enter, entrants must purchase any Stellenbosch Football Club apparel or Webtickets match ticket for the DStv Premiership match between Stellenbosch Football Club and Richards Bay Football Club, provide their name and contact details on their till slip, and insert the till slip at the designated in-store Stellenbosch Football Kiosk at Pick 'n Pay Stelmark Centre, Stellenbosch.
23. Winner selection will be random and the prize will be redeemable from 6 November 2023 – 31 December 2023. The judges' decision is final, and no further correspondence will be entered into.
24. If a winner chosen does not comply, their entry will be disqualified, and a new winner will be selected based on their in-store entry. If a winner cannot be successfully contacted, is ineligible to accept the prize, or contravenes the terms and conditions of this competition, the prize will be forfeited.
25. By entering this competition, a participant is indicating his/her agreement to be bound by these terms and conditions.
